## 2022 Annual General Meeting Minutes

The annual general meeting of members of the Event Atlantic Society was held virtually on Wednesday May 30, 2022 at 10:03am AST.

#### **Welcome and Introduction**

At 10:05am Chair Matt Moore welcomed all to the 2022 annual general meeting of the Event Atlantic Society and served as Chair for the meeting. Stefanie Turner acted as secretary for the meeting.

Matt Moore identified a few key items:

The meeting was being recorded.

The polling feature was used to seek approval from the membership.

Only members of Event Atlantic can vote. When registering to attend, everyone was asked to identify if they were the designated voter for the organization they were representing at the meeting.

#### Credentials

The scrutineer report showed there were 19 individuals present authorized to vote and cast a ballot. The requisite quorum of members was present.

#### **Organization Report**

Matt Moore gave an overview of the past year from January 2021 to May 2022 which included awarding MRSB the contract to create a strategic plan for Event Atlantic, the consultation of over 40 members and several in-person meetings as part of the process. After completion, the strategic plan was adopted in September 2021. As part of the Strategic Plan, the first Excellence Awards was hosted in October at the annual Event Summit, which was the most attended Summit in the history of the program. Throughout the year staff and board members represented Event Atlantic in several capacities including presentations as the Atlantic Recreation Conference, and the Atlantic Mayors congress as well as in a volunteering capacity as numerous events in the region.

The report showed an increase in membership across the region from 86 in 2020 to 94 in 2022. Matt briefly reviewed the priorities and strategies of the 2021-2024 Strategic Plan.

23. The number of directors shall be eight (8). The subscribers to the Memorandum of Association of the Society shall be the first directors of the Society.

23A. Founding partners of Event Atlantic (specifically, City of Charlottetown, City of Moncton, Events Nova Scotia and STEP St. John's) shall serve as ex-officio members of the Board of Event Atlantic. These four (4) seats will be known as "Founding Advisors". The four (4) founding partners can determine who from their organization will represent them.

#### **Election of Directors**

A vote was called for the open seats in Prince Edward Island and Nova Scotia. Bio's were circulated electronically to all registered attendees prior to the AGM. A live vote took place during the virtual AGM. Charlotte Nicholson was the successful candidate for Prince Edward Island, and Paul MacDonald was the successful candidate for Nova Scotia.

### 2022 Financials

The 2022 Event Atlantic Society fiscal year closed with a net surplus of \$67,084 that is being reported today. Government partnerships, strong membership growth, and the Event Atlantic annual conference played key roles in the healthy financial state of the Event Atlantic Society.

Major financial commitments for the 2022 fiscal year included the implementation of a strategic plan and the coinciding administration and coordination that was supported financially by ACOA, and all four provincial governments of the Atlantic provinces.

Event Atlantic Society will commence the 2023 fiscal year with \$74,160.52 in the business account.

### **Board Nominations**
