## 2021 Annual General Meeting Minutes

The annual general meeting of members of the Event Atlantic Society was held virtually, and was recorded, on Thursday June 16, 2021 at 2:00pm AST.

#### Welcome and Introduction

At 2:00pm Chair Matt Moore welcomed all to the 2021 annual meeting of the Event Atlantic Society and served as Chair for the meeting. Stefanie Turner acted as secretary and scrutineer for the meeting.

#### Credentials

The scrutineer report showed there were 17 members in attendance who were authorized to vote and cast a ballot. The requisite quorum of members was present.

#### Approval of the Agenda

Motion to approve agenda as circulated: Paul MacDonald Seconded: Aaron Kennedy All in favour. No objections. Motion Carried

#### Approval of the Minutes

Motion to approve the minutes of the 2020 Annual General Meeting minutes as circulated: Jennifer Shebib Seconded: Tanya Haywood All in favour. No objections. Motion Carried

#### Chair's Report

It has been a tremendous honor and privilege to be nominated by my peers to Chair the Event Atlantic Society for the past year. As we are all well aware – the last several months have been extremely difficult for our sector, and it has been an honor to support recovery efforts. Despite the challenges, the society has continued to make significant strides in member engagement through shared learnings for the adaptation and recovery from Covid-19.



Some of our highlights include:

- A growing membership base reaching an all time high of 93.
- A successful Atlantic Huddle webinar series, in partnership with Events Nova Scotia
- The creation of the Event Atlantic Excellence Awards Program.
- Most importantly, secured important funding to develop and launch a refocused strategic plan, designed to guide our industry down the road to recovery.

#### Amendment proposed:


29. Directors who have, or could reasonably be seen to have, a conflict of interest have a duty to declare this conflict. The declaration should be made to the members.

a) upon nomination, and/or

*b) if serving as a director, when the possibility of a conflict is realized.* 

29A. No funds of the society shall be paid to or be available for the personal benefit of any Director.





## **37.** One of the officers shall be the President. The President shall be responsible for the effectiveness of the board and shall perform other duties as assigned by the members or the directors.

#### Amendment proposed:

37. One of the officers shall be the President. The President shall be responsible for the effectiveness of the board and shall perform other duties as assigned by the members or the directors.

37A. The President shall be appointed to a one-year term. The President shall retire from this position at the end of each annual general meeting, whereafter their successor's appointment will be selected by the Directors. A retiring President shall be eligible for re-appointment.

37B. The outgoing President shall assume the position of Past-President for a one-year term after retiring as President. The Past-President will serve in a training and knowledge sharing ex-officio capacity. The Past-President shall be eligible for re-election as a Director at the conclusion of the one-year ex-officio term. This position may remain vacant if a retiring President is re-appointed for consecutive terms.

Motion to approve the proposed amendment to bylaw #37: Jennifer Shebib Seconded: Tanya Haywood Discussion:

Aaron Kennedy brought forward two questions with possible changes:

37a – Change the word 'APPOINTED' to 'ELECTED' and clarify who shall be responsible for electing/appointing the chair's position

37a – President to serve 2 years versus 1.

Rational for 1-year vs 2-year chair position was explained, discussed, and accepted.

Adjusted bylaw amendment:

37a The President shall be elected to a one-year team by the Event Atlantic board of directors.

Motion to approve the adjusted amendment to bylaw #37: Jennifer Shebib Seconded: Bobby Despres All in favour. No objections. Motion Carried

#### **Election of Directors**

A vote was called for the open seats in Newfoundland and Nova Scotia. Bio's were circulated electronically to all registered attendees prior to the AGM. A live vote took place during the virtual AGM. Tanya Haywood was the successful candidate for Newfoundland, and Matt Moore was the successful candidate for Nova Scotia.





The following slate of candidates were proposed for two-year terms (2020-2022): Bobby Despres – Fredericton, NB Tanya Haywood – St. John's, NL Matt Moore – Truro, NS Emma MacKenzie – Charlottetown, PE

The following candidate was proposed for a one-year term (2020-2021): Paul MacDonald – Sydney, NS

Motion to approve the slate of candidates for one and two-year terms: Aaron Kennedy Seconded: Wayne Long All in Favour. No objections. Motion Carried

Jennifer Shebib declared Bobby Despres, Tanya Haywood, Paul MacDonald, Matt Moore and Emma MacKenzie to be duly elected directors of the Event Atlantic Society. They will be joining returning board members Denis Leblanc, Seamus O'Keefe, Wayne Long.

The Board will subsequently appoint the Officers for the positions of President, Vice President and Treasurer/ Corporate Secretary.

#### **Other Business**

Matt Moore extended appreciation to Stefanie Turner for all the work done on behalf of Event Atlantic during the pandemic. He encouraged everyone to attend the upcoming Event Summit in Halifax as the industry navigates its way out of the pandemic.

## **2020 Financials**

The 2021 Event Atlantic Society fiscal year closed with a net loss of -\$2,155.61 that is being reported today. The continued recovery from COVID-19 was a factor in the bottom line of the Event Atlantic Society financials. The events industry has yet to recover to pre-pandemic levels however a return to an in-person conference in the fall of 2021 occurred.

Major financial commitments for the 2021 fiscal year included the development of a strategic plan and the coinciding administration and coordination that was supported financially by ACOA, and all four provincial governments of the Atlantic provinces.

Event Atlantic Society will commence the 2021 fiscal year with \$18,946.92 in the business account.

## **Proposed By-law Amendments**

An amendment to be voted on by the membership includes item #23 of the Event Atlantic Society Bylaws:

## 23. The number of directors shall be eight (8). The subscribers to the Memorandum of Association of the Society shall be the first directors of the Society.

Amendment proposed:

23. The number of directors shall be eight (8). The subscribers to the Memorandum of Association of the Society shall be the first directors of the Society.

23A. Founding partners of Event Atlantic (specifically, City of Charlottetown, City of Moncton, Events Nova Scotia and STEP St. John's) shall serve as ex-officio members of the Board of Event Atlantic. These four (4) seats will be known as "Founding Advisors". The four (4) founding partners can determine who from their organization will represent them.



### **Board Nominations**

The Event Atlantic Society is made up of 8 board members (Two from every province in Atlantic Canada). Each seat is held for a two-year term with one term expiring from each province every year. Board members whose terms are expiring, have the option to re-offer. If more than one individual puts their name forward, a vote is required to take place at the AGM. This year, a vote is required for the current vacancies in **Nova Scotia and Prince Edward Island**. During the AGM, voting members will be asked to vote for who they would like to see assume the seat for each province. Below are the candidate's bios.
